This workshop will introduce the Aboriginal Performance Wheel and take participants through the core principle of performance reporting in First Nation environments. Subjects covered include:

- Reporting on performance getting started
- Identifying the kinds of information to be reported
- Creating performance reports
- Using performance reports

This workshop is the first to be offered in Canada that tackles the issue of performance reporting in First Nations. The focus is on reporting on performance to **community** members NOT funders.
